About Our Company

Scorpio Gold Corp. (TSX.V: SGN | OTCQB: SRCRF | FSE: RY9) is a Nevada-focused gold exploration and development company dedicated to unlocking the potential of the **Manhattan District**, a newly consolidated package of historic gold assets located within Nevada's world-class **Walker Lane Trend**.

Strategic Location: The Manhattan District sits just 15 kilometres south of Kinross' Round Mountain Mine, one of the largest open-pit gold mines in North America with more than **15 million ounces** of historical production.

Historic Production: Past open-pit mining in the Manhattan District delivered **>2 g/t gold** with industry-leading recoveries of up to **90%**, confirming its high-grade potential.

Recent Transactions:

- In **July 2025**, Scorpio Gold completed the **US\$7.5M sale** of its Mineral Ridge Project.
- In **April 2025**, the Company raised **over \$7M** through an oversubscribed private placement, strengthening its balance sheet for aggressive exploration and resource expansion.

District Consolidation: For the first time, four contiguous gold properties in the Manhattan District have been brought together under Scorpio Gold, creating a **district-scale exploration opportunity**.

Corporate Vision: Scorpio Gold is focused on advancing its **2025 maiden mineral resource estimate** targeting **>500,000 ounces of gold**, while positioning the Manhattan District for significant resource growth in the years ahead.

Investment Highlights

Scorpio Gold presents a compelling investment opportunity, leveraging **historic production, modern exploration, and district-scale consolidation** in one of the world's most attractive mining jurisdictions.

- **Tier-One Jurisdiction:** Nevada ranks among the world's top 2 mining regions, offering stability and infrastructure.

- **District Consolidation:** Four contiguous properties united, creating a district-scale gold exploration opportunity.

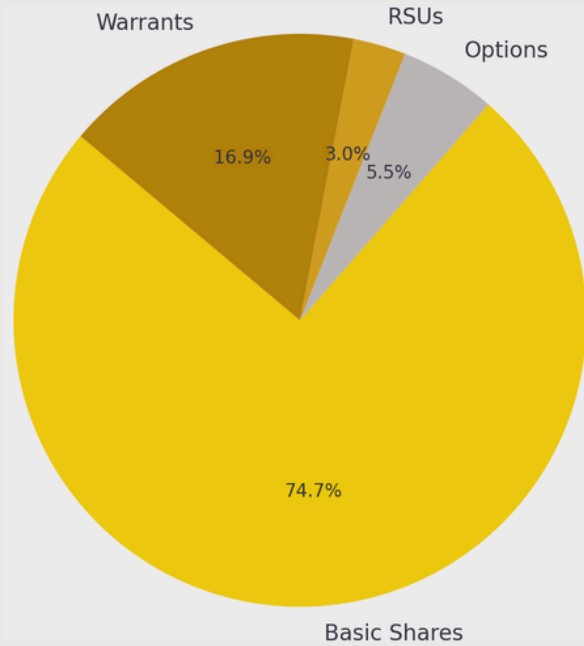


- **High-Grade History:** Past production averaged **>2 g/t Au** with recoveries up to 90%.

- **Financial Strength:** US\$7.5M asset sale (Mineral Ridge, July 2025) + **>\$7M** financing raised (April 2025).

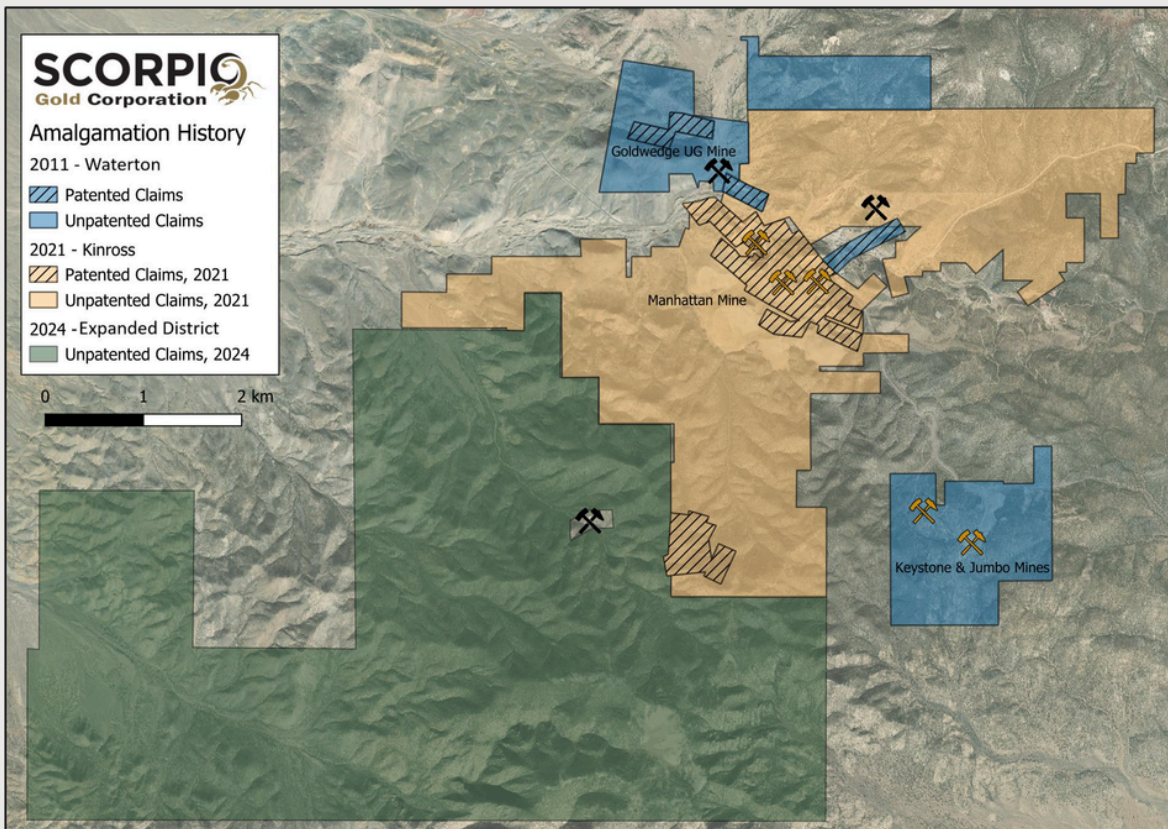
Share Structure

Scorpio Gold is executing a clear growth plan focused on resource definition, exploration, and advancing its Nevada gold assets toward development.

- Deliver a **maiden mineral resource estimate (MRE) in 2025** targeting >500,000 oz Au.
- Expand resources through **step-out and infill drilling** across priority zones.
- Confirm **metallurgical recoveries** and geological continuity.
- Strengthen financial position to support aggressive exploration programs.

Exploration & Resource Potential

Scorpio Gold is advancing the Manhattan District toward a district-scale resource with multiple high-priority targets.

2025 Maiden Resource Goals

- **>500,000 oz Au** initial resource target.
- Average grade projected at **+1 g/t Au**.
- Expansion potential to **2–3x resource size** with continued drilling.

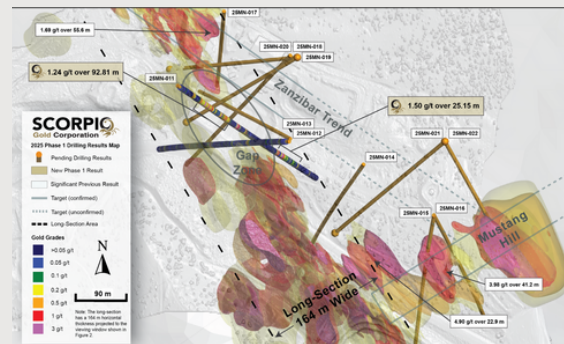


Resource Expansion Strategy

- **Diamond Drilling:** Minimum of 10,000 metres planned in 2025.
- **Geophysics & Structural Surveys:** Downhole televiewer and geophysics to refine targets.
- **Historic Data Review:** Extensive review of legacy drilling, core, and pulps.
- **Metallurgical Testing:** Confirm recoveries and optimize processing flow-sheet.

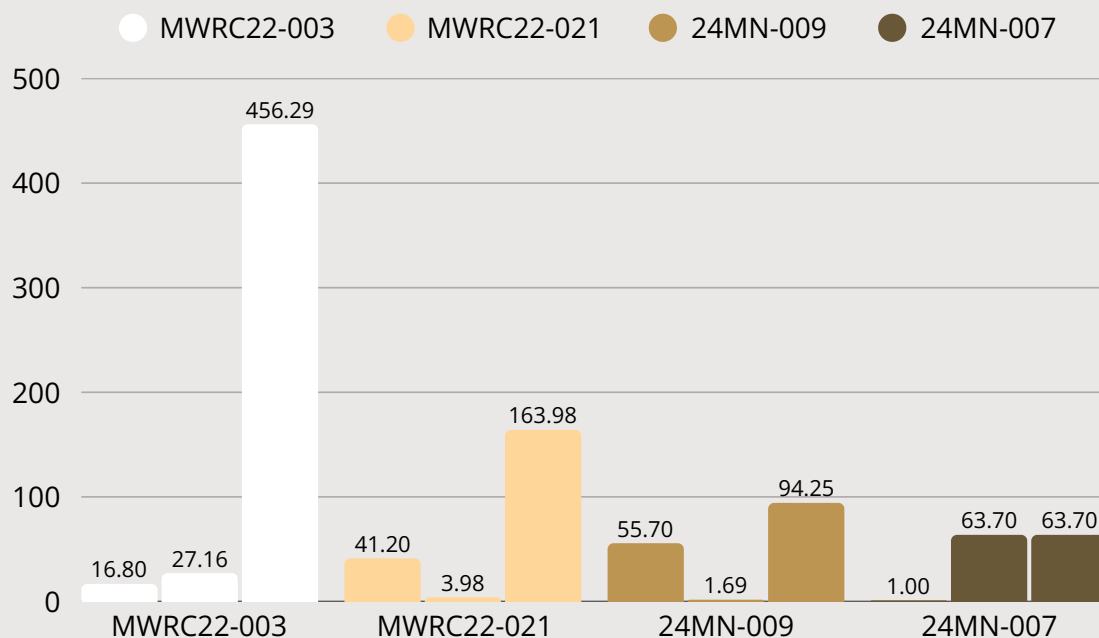
Priority Exploration Targets

- **Gap Zone:** Linking Goldwedge Underground and West Pit.
- **Zanzibar Trend:** Extension between Goldwedge and third target zone.
- **Mustang Hill:** Historic underground workings with strong drill intercepts.



Geology & Mineralization

The **Manhattan District** hosts a **low sulphidation epithermal gold system** adjacent to the historic **Manhattan Caldera**, a proven geologic setting that has produced significant gold ounces in Nevada.



Drilling Highlights

- **MWRC22-003:** 16.8 m @ **27.16 g/t Au** (456.3 g-m).
- **MWRC22-021:** 41.2 m @ **3.98 g/t Au**, incl. 7.6 m @ **15.41 g/t Au**.
- **24MN-009:** 55.7 m @ **1.69 g/t Au**.
- **24MN-007:** 1.0 m @ **63.7 g/t Au**.

Geological Setting

- Hosted in the same caldera complex and geologic formations as **Kinross' Round Mountain Mine** (>15 Moz production).
- Multiple historic mines occur along the **edges of the Manhattan Anticline**.
- Gold mineralization is structurally controlled, concentrated along the **Reliance Fault** and other intersecting structures.

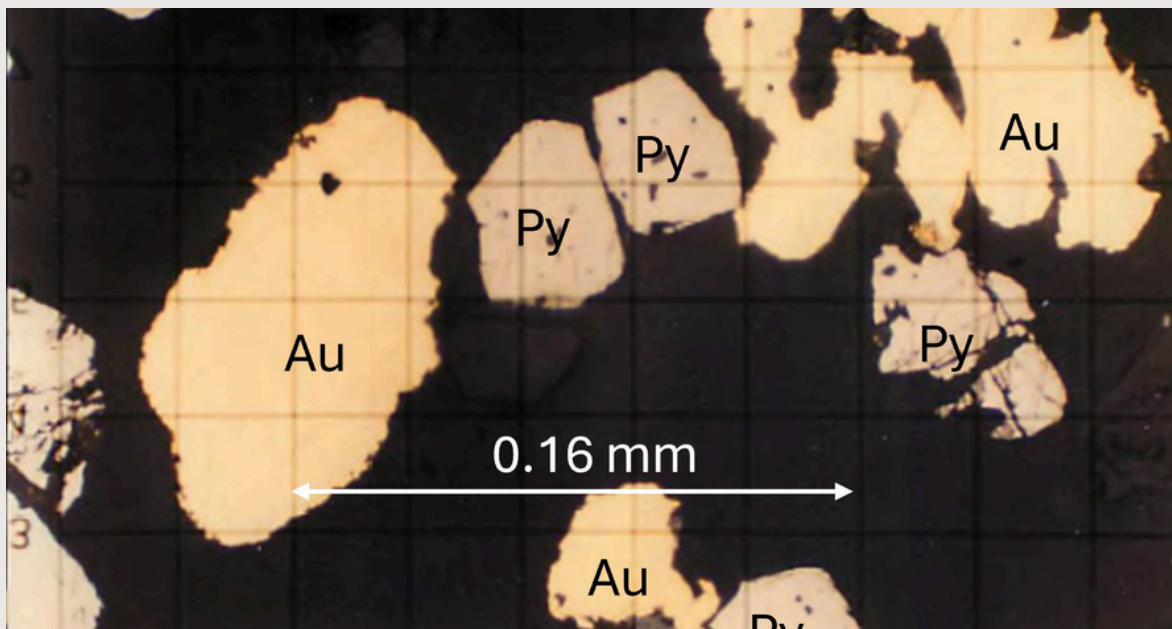
These results confirm the **high-grade nature of mineralization** and the strong potential for **both open-pit and underground development** within the district.

Metallurgy

Gold at the **Manhattan District** is **non-refractory (free-milling)**, which allows for efficient recovery using conventional processing methods.

Historic Recovery Performance

- **Heap Leach (1989–1990, Echo Bay): ~77%** gold recovery.
- **Flotation + Gravity Testing:** Achieved **>90% recoveries**, highlighting strong processing potential.



2025 Metallurgy Program

- **Objective:** Confirm that mineralization is fully amenable to **cyanidation**, as expected.
- **Validation:** Independent testing to replicate and confirm historic recovery data.
- **Flow Sheet Development:** Establish a **preliminary process flow sheet** to support future scoping and feasibility studies.

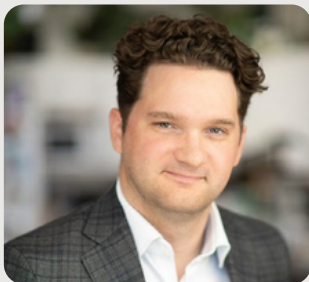
